

Hnab Looj Tes Category Selection Key

Yuav tau siv yog thaum cov PPE uas nyob hauv daim qauv tshuaj tau hais lawm kom yuav tsum tau siv cov hnab looj tes uas tshuaj yeej txeeb tsis tau rau.

Hauv Worker Protection Standard tau tswj lawm, kom txhua daim label qauv tshuaj tua kab uas siv rau tej kev ua teb, thiab tej hav zoov, tej tsev cog yub qoob, thiab cov greenhouse yuav tsum muaj tej khoom tiv thaiv (PPE) uas yuav tsum muab los siv nrog txhua yam uas muaj raws li hais los no. Daim qauv tshuaj label yuav qhia hais txog cov chemical resistance category li (A-H) hais txog cov hnab looj tes. Cov hnab looj tes tau muaj nyob hauv DPR daim paib “Glove Category Selection Key” hnab looj tes category key uas yuav yog cov uas tej tshuaj txeeb tsis tau rau uas nyob rau hauv tej ntaub ntawv qhia txog tej tshuaj tua kab. Cov category yog hais txog cov tshuaj uas ua kua lossis ua hmoov, nws tsis yog hais txog hom tshuaj ntawv. The categories are based on the solvents used in the pesticides, NOT the pesticides themselves. Yog li no, muaj tej zaum nws kuj yog tib hom tshuaj tua kab xwb, tiamsis nws yog ob yam uas nws yog cov ua hmoov, thiab ho tseem muaj cov uas ua kua thiab xws li (wetable powder-WP thiab cov emulsifiable concentrate-EC, piv xam li no) cov no nws yuav hais kom siv cov hnab looj tes hom twg los ntawm ob yam label code categories ntawm nov.

Cov lus uas tau hais lo no hais txog cov hnab looj tes uas yuav tsum muaj qhov tuab li ntawm 14 mils lossis tshaj (Siv li cov laminate thiab cov polyethylene materials).
